## Notification No. MGM/RC/Ph.D.-2024-2025/25/ 2025 dated 10.11.2025 Admission into Ph.D. Programme – 2024-25 in Mathematical and Computational approaches for Community based Sustainable Research as per the Ph.D. Regulations, 2022

Applications are invited from the eligible candidates who have qualified the UGC-NET/UGC-CSIR NET/GATE/SET or any other examinations considered equivalent by the Board of Research Studies of Vidyasagar University and also the candidates those who qualified the Vidyasagar University RET (Research Eligibility Test) 2023-2024 in the subject of Chemistry, Mathematics, Physics, Environmental sciences, Biochemistry for admission into the Ph.D. Programme-2024-25 in the thrust area of Mathematical and Computational approaches for Community based Sustainable Research.

The candidates will have to fill in the Application Form through the online portal of the college website (https://www.mugberiagangadharmahavidyalaya.ac.in), which will be available with effect from 15.11.2025. After successful completion of all the steps (e.g. filling in the personal details, academic details, uploading photo and signature), the candidates will have to pay Rs. 500/- (Rupees Five hundred) only (plus convenience fee & GST, if applicable) for all category as application fee for the Ph.D. Programme through online mode of payment (credit card / debit card /net banking etc.) only. The last date for submission of online application is 30.11.2025.

## Eligibility Criteria for admission to Ph.D. Programme:

Candidate who has completed 2-year/4-semester Master's Degree after a 3-year Bachelor's Degree or qualifications declare equivalent to the Master's Degree by the corresponding statutory regulatory body in the subject of Chemistry, Mathematics, Physics, Environmental sciences, Biochemistry shall be eligible for admission. The candidate has to obtain at least 55% marks in the General Category and 50% marks in the SC/ ST/OBC (non-creamy layer) Persons with Disabilities, Economically Weaker Section (EWS) categories.

However, the following provisions are to be noted:

- I. Application of the candidates failing to fulfill minimum eligibility criteria of admission will be rejected:
- II. The candidate is not currently admitted as a student in any full-time course of studies or registered for doing Ph.D. in any university,
- III. Selection of candidates for admission into the Ph.D. programme will be made through an interview to be conducted by the Vidyasagar University.
- IV. The admission of ST, SC, OBC-A and OBC-B candidates will be as per norms.
